Description

- A.) DESKTOP COMPUTERS (2 units) – Intel Core i7 processor, 3.7 GHz, 2048 Mb memory; HD Graphics 1GB (F-860-a), 500Gb SATA-II 7,200-rpm, up to 4GB DDR3L at 1600MHz – 1 DIMMS, Socket LGA 115, 650W AX1500i PSU, Small tower computer case, ES500 UPS, 23" LED monitor, USB type keyboard, USAB Optical mouse
- B.) PROJECTOR (4 units) – QR code connectivity, WXGA resolution, 3000 lumens brightness, HDMI & MHL connectivity
- C.) PORTABLE SPEAKER (2 units) – wireless, 29 watts/5.25-inches subwoofer, 20Hz-20kHz frequency response, 16 ohms impedance, 102dB sensitivity, 3.5mm auxiliary input and output, Bluetooth v2.1 range up to 10m, with AAC & support for A2DP, HFP and HSP protocols, boombox-style speaker delivers crisp, precise audio

- E.) HANDHELD RADIO (6 units) – 75mW loud and intelligible audio output, 5.5W high power output, IP54 and MIL-STD-810 rugged construction total of 207 memory channels, built-in CTCSS/DTCS, with internal VOX function
- F.) SHREDDER (1 unit) – touch top function, 3.5mm shred size, ≤10 Shred Capacity (A4/50g, pcs/times), 3.1m/min shred speed, with overheat protection, paper feed/reverse functions, 220mm feed port width, 420*340*625mm packing size, 350*262*570mm machine size; machine weight of 12.6 kg, 220V/50Hz power supply, 155W power and -5 – 40 °C working temperature
