



Invitation to Bid

COMPLETION OF ACADEMIC BUILDING III (LABORATORY BUILDING)

1. The Philippine Science High School – Central Visayas Campus (PSHS-CVisC) through the General Appropriations Acts (GAA) 2014 and 2015 intends to apply the sum of **thirty nine million one hundred ninety eight thousand four hundred eighty four pesos (Php39,198,484.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Completion of Academic Building III (Laboratory Building)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PSHS-CVisC now invites bids for the **Design and Build of the COMPLETION OF ACADEMIC BUILDING III (LABORATORY BUILDING)**. Completion of the Contract is required within **240 calendar days** from the effective date of the contract. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the Bids and Awards Committee (BAC) of PSHS-CVisC and inspect the Bidding Documents at the address given below **during weekdays from 8:00am to 5:00pm**.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **twenty five thousand pesos (php 25,000.00)** only. Payment for the bidding documents should be made to the cashier's office of PSHS-CVisC. Bid Documents will be available until August 27, 2015.
6. The BAC of PSHS-CVisC will hold a **Pre-bid Conference on August 07, 2015 (2:00pm)** at the Conference Room of the Admin. Bldg. which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before **August 28, 2015 (2:00pm)** at the **BAC Office of PSHS-CVisC, Talaytay, Argao, Cebu**. All bids must be accompanied by a bid security in any of the acceptable forms as stated in the Bidding Documents.

Bids will be opened in the presence of the bidders' authorized representatives (*with authorization letter duly signed by the bidder*) who choose to attend at the address below. Late bids shall not be accepted.
8. The **PSHS-CVisC** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
