The design and build contract include among others, the preparation of all necessary detailed engineering investigations, surveys and designs in accordance with the provisions of Annex G of RA 9184 and its IRR except the preparation of bidding documents and ABC. Bids receive in excess of the ABC shall automatically be rejected at the opening of the financial proposals. "Partial Bids" are not allowed.

The list of the minimum requirements is indicated in the Eligibility Form. Eligibility of prospective bidders shall be checked using a nondiscretionary "pass or fail" criterion. Prospective bidders should have at least one similar project, both in design and construction, with at least 50% of the cost of the ABC. A two-step procedure shall be adopted in the detailed evaluation of the design and build proposals. The first-step procedure of the evaluation shall be based on these criteria: (a) Adherence of preliminary design plans to the required performance specifications and parameters, Terms of Reference and degree of details; (b) Concept of approach and methodology including Value Engineering Analysis; and (c) quality of personnel to be assigned to the project . The second-step procedure shall be the opening and evaluation of the financial proposals of those bidders who are compliant to the criteria in the first - step procedure.

All particulars related to the bidding process (Eligibility Screening, Bid Security, Performance Security, Pre-bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract) shall be governed by the pertinent provisions of RA 9184 and its Implementing Rules and Regulations (IRR) 6th Edition.
