Description:

- Venue of the activity: within Cebu (preferably southern part);
- No. of participants: 15;
- Inclusions: (provision of 1 tarpaulin)
- Room Requirements (1 room good for 5 persons and 1 room good for 10 persons for 2 nights only)
- Food: BUFFET; Full board meal with AM and PM snacks; 1 main courses (choice of meat, fish, chicken, vegetable); with 1 side dish; drinks (choice of fruitdrink, ice tea / coffee every meal);
- Snacks: (choice of chicken empanada, banana flitters, chicken sandwich, waffle, puto cheese, pasta, cassava or banana cake)

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post – qualification of the lowest calculated bid shall be conducted.


