INVITATION TO BID

The Bids and Awards Committee (BAC) of the Philippine Science High School – Central Visayas Campus (PSHS-CVisC) now invites agencies/potential bidders to bid for the aforementioned project to wit:

Location : *PSHS - Central Visayas Campus, Talaytay, Argao, Cebu*
Project Title : *Provision of Internet Services and Network Solution*
Approved Budget for the Contract : *Php 495,000.00*
Contract Duration : *12 months*

Scope of Work: (a.) supply and installation of at least 15Mbps internet connection with landline; (b.) installation of wireless backhaul or wireless Ethernet bridge; (c.) installation of firewall; (d.) installation, configuration, and deployment of VOIP phone with telefax capability; (e.) installation of two 24-gigabit managed switches, two UPS with AVR, Ethernet surge protector, grounding rods, one roll shielded cat6 cable; (f.) phone, e-mail, and on-site support; (g.) assistance integration to existing network infrastructure; (h.) quarterly preventive maintenance/system check; (i) complete implementation documentation turn-over with installers, CD & hardbound for engineering and operations

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding and have key personnel and equipment (owned, leased or under purchase) available for the implementation of the project. The list of minimum equipment requirement is indicated in the Eligibility Forms. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-bidding Conference (s), Evaluation of Bids, Post-Qualification and Award Contract shall be governed by the pertinent provisions of RA 9184 and its revised Implementing Rules and Regulations (IRR-A) latest edition.
