Project Description: The project includes the supply of the following materials for the Fabrication of MRF: (1.) GI Pipes, 1.5" dia or 38mm dia - 15 lengths; (2.) GI Pipes 1" dia - 6 lengths; (3.) Steel matting #8, 2"x6'x10' (50.8mm x 1.8m x 3.0m) - 4 pcs; (4.) Welding Rod - 10kg; (5) Tekscrew 2.5" 12"x 65" - 1.50" - 1000pcs; (6.) wheels 6" - 6pcs; (7.) Angle bar 2"x2"x0.25" - 2 lengths; (8.) Epoxy Primer (Enamel) - 2 gallons; (9.) Lacquer Thinner - 1 gallon; (10.) paint brush (4" x 101mm) - 4 pcs; (11.) gloves - 10 pcs; (12.) Trash Bin 120L, swing-top type made of durable plastic materials (red, blue, green, black) - 16 pcs; and (13.) metal frame, made of angle bars (1.5"x1.5"x0.25"), fitted for 4 pcs trash bins, painted with black - 4 pcs.

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 25% of the proposed project for bidding. The Eligibility Check as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post – qualification of the lowest calculated bid shall be conducted.
