*Location* : *PSHS - Central Visayas Campus, Talaytay, Argao, Cebu*  
*Project Title* : *Provision of Furnitures*  
*Approved Budget for the Contract* : *Php 99,000.00*  
*Contract Duration* : *2 months*

**Scope of Work:** *The works includes supply of the following: (a.) benches – 6 units; (b.) corner table – 1 unit; (c.) corner stand – 1 unit; (d.) divider – 1 unit; (e.) TV rack wall mounted – 1 unit; (f.) computer table – 3 units; (g.) glass pad 4.5ft -2.12ft; (h.) rack (key holder) – 1 unit; and (i.) study table – 3 units*

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding and have key personnel and equipment (owned, leased or under purchase) available for the implementation of the project. The list of minimum equipment requirement is indicated in the Eligibility Forms. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary “pass/fail” criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-bidding Conference (s), Evaluation of Bids, Post-Qualification and Award Contract shall be governed by the pertinent provisions of RA 9184 and its revised Implementing Rules and Regulations (IRR-A) latest edition.
