

- Certified true copy of Securities and Exchange Commission (SEC) Registration or Department of Trade & Industry (DTI) Registration, and
- List of works done with contract amount and name of respective clients

Offer/Quotation exceeding the Approved Budget for the Contract (ABC) shall be rejected.

PSHS –CVisC reserves the right to accept or reject any offer/quotation, to reject all offer/quotation at any time prior to contract award, to exclude any item or reduce the number of units and the corresponding ABC as determined by PSHS-CVisC and to award the contract to the bidder with the most advantageous offer, without thereby incurring any liability to the interested parties.
