## INVITATION TO BID

## COMPLETION OF ACADEMIC BUILDING III (LABORATORY BUILDING) PHASE IV

(ITB - 2017 - 119)

- The Philippine Science High School Central Visayas Campus (PSHS-CVisC), thru the General Appropriations Act (GAA) 2017 of the GoP, intends to apply the sum of Eighteen Million Two Hundred Forty Four Thousand Seven Hundred Fifty Pesos (Php18,244,750.00) only, being the Approved Budget for the Contract (ABC) to payments under the contract for the project, Completion of Academic Building III (Laboratory Building) Phase IV.
  - Bids received in excess of the ABC shall automatically be rejected during the bid opening. Scope of work includes construction works such as earthworks, concrete works, finishing works, plumbing works, electrical works, mechanical works, doors and windows and fire protection system as stipulated in the Bill of Quantities, Technical Specifications and Working Plans/Drawings. "PARTIAL BID" IS NOT ALLOWED.
- The PSHS-CVisC, through its Bids and Awards Committee (BAC), now invites contractors registered with the PhilGEPS, PCAB and have valid and business permits and licenses, to apply for eligibility and to bid for the project, Completion of Academic Building III (Laboratory Building) Phase IV. Completion of Works is required within three hundred (300) calendar days from the effective date of the contract.
  - Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a single contract similar to the Project with a contract amount equivalent to at least 50% of the ABC. The complete description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding shall be conducted through Open Competitive Bidding procedures using a non-discretionary "pass/fail" criterion as specified in Rule IX Section 30 - 32 of the Revised Implementing Rules and Regulations (IRR) of the Republic Act (RA) 9184, the "Government Procurement Reform Act".
- Interested bidders may obtain further information and inspect the Bidding Documents at PSHS-CVisC, Talaytay, Argao, Cebu from Monday-Friday starting June 14, 2017 from 8am up to 5pm.

## **SCHEDULE OF ACTIVITIES**

A complete set of Bidding Documents may be purchased by interested Bidders starting June 14, 2017, during office hours, 8am – 5pm from the address stated above and upon payment to the PSHS-CVisC cashier, of a non-refundable fee for the Bidding Documents in the amount of twenty five thousand pesos (php25,000.00) only.

It may also be downloaded free of charge from the website of the PSHS-CVisC and the PhilGEPS, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

- The BAC will hold a Pre-bid Conference on June 23, 2017 (4:00pm) at the Admin Bldg, PSHS-CVisC, Talaytay, Argao, which shall be open only to all interested parties who have purchased the Bidding Documents.
- Bids should be delivered to PSHS-CVisC on or before 4:00pm of July 6, 2017. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 18.
  - Bid Opening shall be on July 6, 2017 at exactly 4:00pm at the Admin Bldg, PSHS-CVisC, Talaytay, Argao, Cebu. Bids shall be opened in the presence of the Bidders' representatives who choose to attend at the address given below. Late bids shall not be accepted.
- PSHS-CVisC assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid.
- The PSHS-CVisC reserves the right to accept or reject any bid, annul the bidding process, and to reject all bids at any
  time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
