INVITATION TO BID

PURCHASE OF AIRCONDITIONING AND AUDIO-VISUAL EQUIPMENT (ITB - 2018 - 06b)

1. - 5. The BAC will hold a Pre-bid Conference on June 15, 2018 (2:00pm) at the Admin Bldg, PSHS-CVisC, Talaytay, Argao, which shall be open only to all interested parties who have purchased the Bidding Documents.
- 6. Bids should be delivered to PSHS-CVisC on or before 2:00pm of June 28, 2018. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid Opening shall be on June 28, 2018 at exactly 2:00pm at the Admin Bldg, PSHS-CVisC, Talaytay, Argao, Cebu. Bids shall be opened in the presence of the Bidders' representatives who choose to attend at the address given below. Late bids shall not be accepted.
