



INVITATION TO BID

(ITB – 2018 – 29)

SUPPLY, DELIVERY AND INSTALLATION OF FURNITURES AND FIXTURES FOR ACADEMIC LABORATORY

1. Philippine Science High School – Central Visayas Campus (PSHS-CVisC), thru the General Appropriations Act (GAA) 2018 under capital outlay of the GoP, intends to apply the sum of **Thirteen Million Nine Hundred Ten Thousand Pesos (Php 13,910,000.00)** only, being the Approved Budget of Contract (ABC) for the project: **Supply, Delivery and Installation of Furnitures and Fixtures for Academic Laboratory.**

Bids received in excess of the ABC shall automatically be rejected during the bid opening.

Scope of work to be undertaken includes supply and installation of various furnitures and fixtures for the upper ground floor (physics laboratory), second floor (biology laboratory), and third floor (chemistry laboratory). Furnitures and fixtures to be installed in any or all of the floors include, laboratory center table with chairs, demonstration table with sink, platform, laboratory counter, laboratory sink, chemical cabinets, hanging cabinets, black curtain for dark room, gas & water fittings, electrical outlets, eye wash with shower, display cabinets, among others that the contractor may deemed necessary for the optimal functionality of this laboratory building.

2. The PSHS-CVisC, through its Bids and Awards Committee (BAC), now invites suppliers registered with PhilGEPS and have valid licenses appropriate for the project, to apply for eligibility and to bid for the project, **Supply, Delivery and Installation of Furnitures and Fixtures for Academic Laboratory.** Completion of the project is required within **one hundred fifty (150)** calendar days from the effective date of the contract.

Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a single contract similar to the project. The complete description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding shall be conducted through Open Competitive Bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 IRR of Republic Act (RA) 9184, the “Government Procurement Reform Act”. Provisions of Section 23, 25 and 27 on procurement of Goods in the RA shall be followed.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information and inspect the Bidding Documents at PSHS-CVisC, Talaytay, Argao, Cebu from Monday-Friday on **November 30, 2018 to December 19, 2018** within office hours (8am up to 5pm).



SCHEDULE OF ACTIVITIES

A complete set of Bidding Documents may be purchased by interested Bidders starting **November 30, 2018**, during office hours, 8am – 5pm from the address stated above and upon payment to the PSHS-CVisC cashier, of a non-refundable fee for the Bidding Documents in the amount of **twenty-five thousand pesos** (php 25,000.00) only.

It may also be downloaded free of charge from the website of the PSHS-CVisC and the PhilGEPS, provided that, bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

5. The BAC of PSHS-CVisC will hold a Pre-bid Conference on **December 7, 2018 (9:00am)** at the Admin. Bldg, PSHS-CVisC, Talaytay, Argao, Cebu which shall be open to all interested parties.

6. Bids should be delivered to PSHS-CVisC on or before **9:00am of December 19, 2018**. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid Opening shall be on **December 19, 2018 at exactly 9:00am** at the Admin Bldg., PSHS-CVisC, Talaytay, Argao, Cebu. Bids shall be opened in the presence of the Bidders' representatives who choose to attend at the address given below. Late bids shall not be accepted. Bid evaluation and post-qualifications of bids shall be done on **December 20-21, 2018**.

7. PSHS-CVisC assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid.

8. The PSHS-CVisC reserves the right to accept or reject any bid, annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.


